Michael Draper provided a brief PowerPoint presentation highlighting key components of the proposed policy. He said the policy is replacing Division X of Chapter 12 of the MCWD Code and closely aligns with current California regulations as well as the District's Water Shortage Contingency Plan. The policy is meant to clearly communicate landscaping guidelines and the permitting process to District customers, with the goal of promoting water efficiency and conservation.

#### Mono LAFCO:

Director Cage reported that the notable agenda item at Mono LAFCO's meeting was the preliminary Fiscal Year 2024-25 budget. He said MCWD's portion of the projected budget is expected to increase from \$1,857 to \$2,725 for the year. The significant increase is due to the cost of conducting 26 Municipal Service Review (MSR) updates.

Garrett Higerd added that the District's Sphere of Influence (SOI) needs to be updated, primarily because of the ski area's Main Lodge re-development project. The MCWD Board should review and update the District's SOI in order to make a recommendation to Mono LAFCO before the District's MSR is completed.

Mr. Higerd added that the Main Lodge joint EIR/EIS is expected to be released in 2025. It will be important for both agencies (MCWD and Mono LAFCO) to thoroughly review the reports and provide comments related to expanded water and sewer service to the proposed development.

Director Cage said the Commission also discussed the LAFCO Membership Roster and the steps to fill the current and upcoming vacancies.

#### Ad-Hoc Code/Policy Committee:

Director Smith said the committee met and discussed the policies that were acted upon earlier in this meeting. Director Domaille complimented Michael Draper for his work on the new Landscaping Standards Policy.

#### **Employee Housing Committee:**

Director Smith said the committee discussed the goals of the housing program and more information would be provided during the upcoming closed session.

#### Technical Services Committee:

Director Domaille said there were many topics discussed at the meeting. The most notable was the discovery of a tremendous source of I&I (infiltration & inflow) into the District's wastewater plant. Rob Motley elaborated on the story and described how the Line Maintenance team, through regular inspection, discovered an enormous volume of clear water infiltrating into some abandoned sewer laterals in the Sierra Valley Sites neighborhood. Following the excavation and repairs, staff estimated that the discovery reduced the plant's daily inflow by approximately 20%.

The committee was also updated on the failure of a section of sewer pipe that had been sliplined as part of the annual rehabilitation project in 2022. The contractor that did the original work is standing behind their work and is being very proactive about correcting the failure.

Also discussed was the status of the regular third-party sampling and testing of groundwater for potential impacts due to Ormat's CDIV project.

Additionally, there are several summer projects in various phases of the bidding process.

### 2. Presentation on the Status of the Snowcreek VIII Development Proposal and Possible Direction to Staff Regarding Terms for Amending the Snowcreek Recycled Water Service Agreement

Garrett Higerd provided the Board with a detailed overview of the Snowcreek VIII development project and the developer's request to amend the recycled water service agreement between Snowcreek and MCWD. The current agreement was signed in 2010 and has been amended three times since.

The developer, Chuck Lande, spoke and said he would like to cease taking and using the District's recycled water for golf course irrigation in 2025 and 2026. He said that construction of the Snowcreek VIII project requires the existing recycled water pond to be relocated, taking it offline in the meantime. He is asking to use raw well water or potable water for the existing golf course irrigation and any common area irrigation that would come online in the interim while the recycled water is offline. Mr. Lande assured the Board that the project's construction plan has the new recycled water pond online in 2026, but he would like an extra construction season as a contingency. He also stated that they may or may not build the second 9-holes extending the existing golf course to 18-holes.

Board members expressed concern about allowing the Snowcreek development to use raw or potable water for golf course and common area irrigation if the District were to increase its water conservation level during the next couple of years. Michael Draper noted that a golf course using potable water for irrigation would need to submit a comprehensive water conservation plan consistent with the District's conservation level at the time. The Board asked about completing construction of the new recycled water pond if changing economic conditions slowed down construction at Snowcreek VIII. Mr. Lande assured the Board that changing economic conditions would not delay completion of the recycled water pond.

There was additional discussion regarding the District's production capability as well as the recycled water storage capacity of both Snowcreek and Sierra Star golf courses and the commitment to serve each golf course.

Following a lengthy discussion, the Board directed staff to work with legal counsel to amend the 2010 recycled water agreement and bring it back in July for approval. The amendments are to include:

- Allow a 2-year (2025 and 2026) hiatus in recycled water service while a new pond is constructed.
- The Snowcreek VIII common area will be irrigated with recycled water and subject to WELO (Water Efficient Landscape Ordinance).
- No commitment to build and serve an additional 9-hole golf course is being requested at this time.

#### **Background**

MCWD entered into a Memorandum of Understanding (MOU) with Mono County for the purpose of allowing Mono County staff access to wastewater treatment plant influent flows for sampling and analysis of wastewater within the District to determine the presence of communicable diseases. The term of the MOU was January 20, 2023, through June 30, 2024. The MOU contains a provision that the term may be extended for one or two-year terms by mutual written consent of the District and Mono County.

Throughout the term of the agreement the Mono County Health and Human Services Department, Public Health Division collected wastewater samples from the MCWD treatment facility on a weekly basis for sampling and analysis by a lab to determine the concentration of virus present. Results are made publicly available on Mono County's website.

#### **Discussion**

The Mono County Division of Public Health now wishes to extend the MOU by a two-year term and make clerical amendments to update the MOU to continue sampling and analysis. District counsel has reviewed and approved Mono County's proposed MOU amendments. On July 9, 2024, the Mono County Board of Supervisors approved the amendment and sent it to the MCWD Board for their consideration.

#### **Fiscal Impact**

There is no fiscal impact to the District.

#### **Requested Action**

Staff recommends approval of and direction for the General Manager to sign a two-year extension of the MOU to allow Mono County staff access for wastewater sampling.

# AGREEMENT AND FIRST AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE COUNTY OF MONO AND MAMMOTH COMMUNITY WATER DISTRICT REGARDING WASTEWATER SAMPLING AND ANALYSIS

This Agreement and First Amendment is entered into June \_\_\_\_, 2024 by and between the County of Mono (hereinafter, "County"), a political subdivision of the State of California, and Mammoth Community Water District of Mammoth Lakes, California (hereinafter, "MCWD"), for the purposes of amending that certain Memorandum of Understanding between the County and MCWD entered into on or about February 22, 2023, for the purpose of setting forth the mutual understanding of MCWD and County regarding the sampling and analysis of wastewater within the MCWD to determine the presence of communicable diseases (the "MOU"). The County and Contractor are sometimes referred to herein collectively as "the parties."

WHEREAS, the parties entered into the Agreement for the purpose of setting forth the mutual understanding between the parties regarding the sampling and analysis of wastewater within the MCWD to determine the presence of communicable diseases; and

WHEREAS, the term of the MOU is set as January 20, 2023 through June 30, 2024, and

**WHEREAS**, the MOU contains a provision that the term may be extended for one or two-year terms by mutual written consent of the Parties; and

WHEREAS, the Parties wish to extend the contract by a two-year term, and make clerical amendments to the MOU.

#### **NOW, THEREFORE**, the parties agree as follows:

1. Paragraph 1 ("Term") of the Agreement is hereby extended for two years, and amended to read as follows:

"The term of this Agreement shall be from January 20, 2023 to June 30, 2026, unless sooner terminated as provided below."

2. Paragraph 9 ("Party Representatives") be modified to read as follows:

#### **Background**

Since June 1999, Mammoth Community Water District has had a lease with the USGS for use of office space and areas which allow for the placement of equipment used by USGS to support their on-going volcanic and seismic hazards monitoring program for the Long Valley Caldera area. The original lease expired in June of 2009 and was renewed with a termination date of June 30, 2020. The MCWD Board of Directors approved a two-year extension of the lease in 2020 and again in 2022, which expired June 30, 2024.

#### **Discussion**

The USGS and the District desire to continue the positive and cooperative arrangement that the parties have had for the past 25 years. The District and USGS have been working on an updated longer-term lease, but in the meantime a short-term, two-year lease extension is proposed to prevent any disruption to daily activities.

The annual rental amount listed in the 2022 lease extension was set at \$10,455, paid in monthly installments of \$871.25. The proposed two-year supplemental lease agreement includes a 2.5% annual increase to the monthly rent equaling \$10,984.29 annually or \$915.35 per month.

Attached to this consent agenda item is the updated lease agreement extension as well as the original lease executed in 2009.

#### **Fiscal Impact**

If the extension is approved, the District will realize \$22,243 in total revenue over the term of the lease through 2026.

#### **Requested Action**

Staff recommends approval of and authorization for the General Manager to sign a two-year extension of the USGS lease to help support an important long-term federal scientific and public safety service to the Mammoth area.

- B. For Cause. The Government may also terminate this Lease upon default by Lessor by giving at least thirty (30) days notice in writing to the Lessor and no rental shall accrue after the effective date of termination for cause and/or if Lessor defaults.
- 7. ANTI-DEFICIE \*CY ACT. The Government\* obligation to pay rent or any other charge under this Lease is contingent upon the appropriation of funds for the purposes of this Lease and is further contingent upon the availability of funds from which payment for rent or other charges under this Lease can be made.
- 8. INGRESS/FGRESS. Lessor hereby grants to the Government, its contractors, agents and other duly assigned p resonnel, the right of ingress and egress (both vehicular and pedestrian), necessary or convenient for the installation, use, maintenance, repair, operation, and replacement of government owned communication equipment across Lessor's property.
- 9. GOVERNMENT INSPECTION. The Government reserves the right, at any time after the Lease is signed and during the term of the lease, to inspect the Premises and all other areas of the building to which access is necessary to ensure a safe and healthy work environment

for the Government tenants and the Lessor's performance under this Lease.

10. ANTENNA AND EQUIPMENT INSTALLATION AND OPERATION. The Government shall have the right during the term of this Lease to install, operate, maintain, repair, and replace upon the Premises, including but not limited to any tower or other improvement presently existing or to be constructed upon the Premises, the equipment identified in Exhibit A, and any equipment or infrastructure necessary for, or related or ancillary to, the operation, performance, and maintenance of the equipment identified in Exhibit A (said antenna or antennas, equipment and infrastructure hereinafter called, collectively, the "Antenna System"). The Government is solely responsible for all eosts connected with the installation and maintenance of the Antenna System. The Antenna System shall remain the property of the Government and may be removed or otherwise disposed of by the Government. Upon termination of this Lease, the Lessor shall permit the Government all reasonable access to the Premises for the purposes of removing or otherwise disposing of the Antenna System or any part thereof, and the Government shall conduct its removal of the Antenna System or any part thereof in a reasonable and safe manner and within a reasonable period of time, in accordance with all Federal, state, and local law.

- 11. FOLIAGE CLEARANCE/DEBRIS REMOVAL. The Government may periodically trim and remove foliage and debris from the premises and from all other areas under the Lessor's control, access to which is necessary to accomplish the purpose of ingress and egress to the premises, and to ensure the operational performance of the Amenna System.
- 12. DESTRUCTION OF SPACE. If the Leased area is partially or totally destroyed or damaged by fire or other easualty so that the Leased space is untenantable ("Destruction of Space"), as determined by the Government, and the Lessor elects to rebuild or restore the leased area then government will have the opportunity to reestablish the antenna system to the said premises under the existing terms of this lease. During the period in which Lessor is rebuilding or restoring the leased area, no Lease charge is to be incurred by the Government. Any such payments, by the Government to the Lessor will be promptly returned to the agency listed in section 5.

In the event of Destruction of Space, either party may also elect to terminate this lease by providing the other party with filteen (15) days written notice of such termination.

This paragraph 12 replaces the clause 552.270-7 (Fire and Casualty Damage) in the General Clauses which are attached to this Lease and made a part hereof.

- 13. EMERGENCY BACKUP ON DESTRUCTION. If the leased area is partially or totally destroyed or damaged by fire or other easualty so that the Leased space is untenantable, as determined by the Government, Government may provide contingent communications equipment within 24 hours of the destruction. Notwithstanding the foregoing, Government shall at all times comply with the requirements of Section 14 herein.

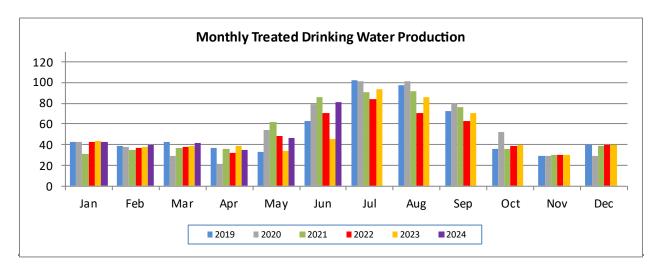

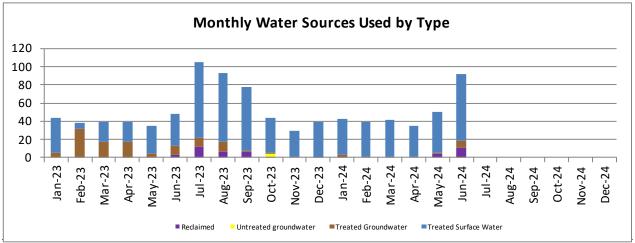
## Monthly - Water Treatment, Production & Supply Management

#### • Drinking Water Treatment

Routine samples for clarity, chlorine residual, and bacteriological analysis of the District's drinking water were conducted during the month. The results of all sampling for the month were in compliance with the standards set by the State Water Resources Control Board Drinking Water Division. A total of 80,973,000 gallons were treated for drinking water with an average of 2.7 million gallons per day. Drinking water was produced from surface and groundwater supplies, 91% and 9% respectively.

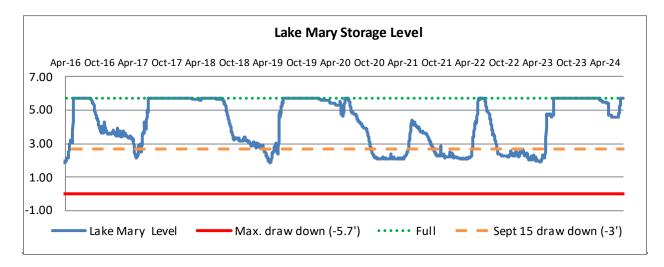


Operations Department Report July 2024



#### Surface Water

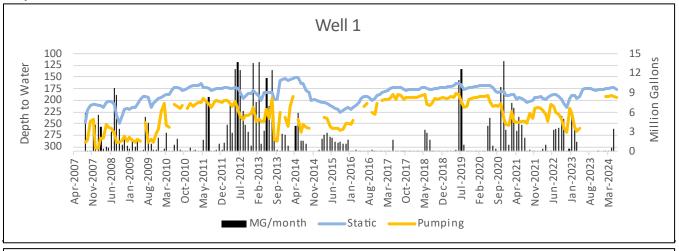
The minimum daily stream flow requirement for the month of June was 20.8 cfs for Mammoth Creek, as measured at Old Mammoth Road. Flow rates in the creek ranged from 24 cfs to 115 cfs with an average flow of 59 cfs. The flow requirement for July decreases to 9.9 cfs and current flows are above requirement. Lake Mary is currently full with a balance of 606 ac-ft in storage. Surface water will continue to be the primary source of supply using direct diversion.

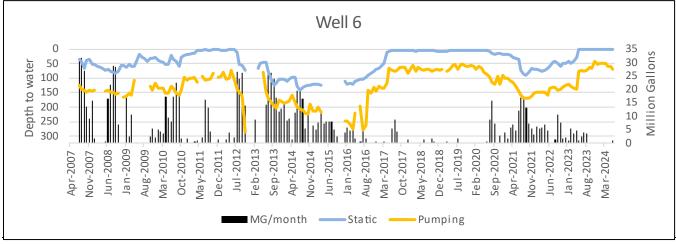


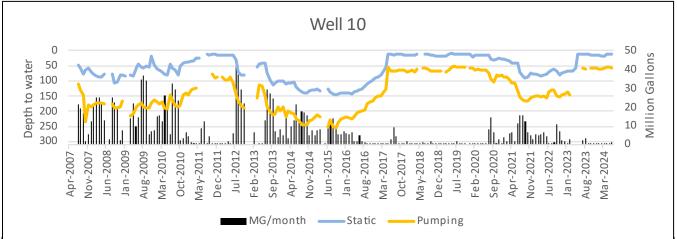

Approximately 7,452,000 gallons or nine percent (9%) of the drinking water produced was from the District's groundwater sources during the month of June. Groundwater production Wells 1, 6, 10, 15, 17, 18, 20, and 25 are operating as expected and are available for service.

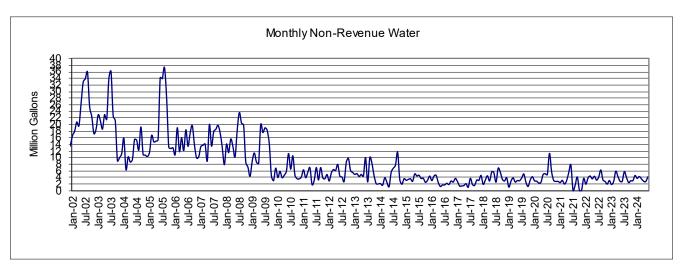

# July 2024Water Audit Information

The water audit for this billing period shows a total of 4.06 million gallons of non-revenue water. The annual non-revenue water for 2023 was 7% and well under the 10% AWWA standard.

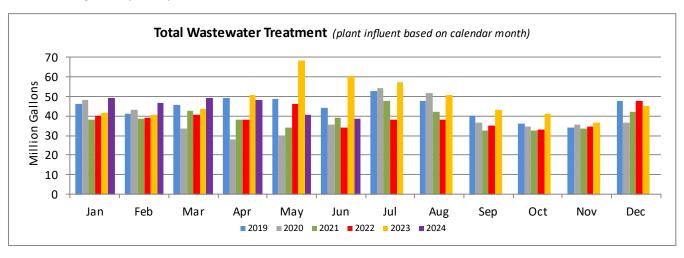
Wastewater treatment samples have met all compliance requirements for the month.

#### Recycled Water

Recycled water production commenced in May for Sierra Star golf course and the trucked water program. The total recycled water delivery to Sierra Star for June was 10,550,000 gallons. Snowcreek has not purchased any recycled water this season.

#### Wastewater Flows

The total volume of wastewater treated during the month of June was 38.42 million gallons. This results in an average of 1.28 million gallons per day of wastewater flow.

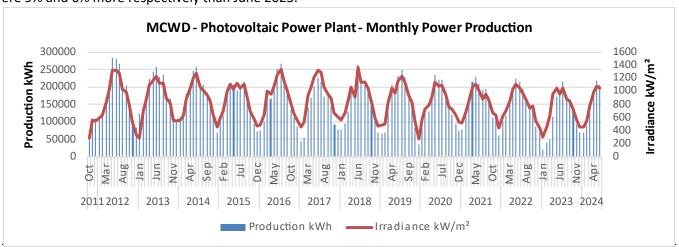

## **Photovoltaic Power Plant Operations & Total District Electrical Usage**

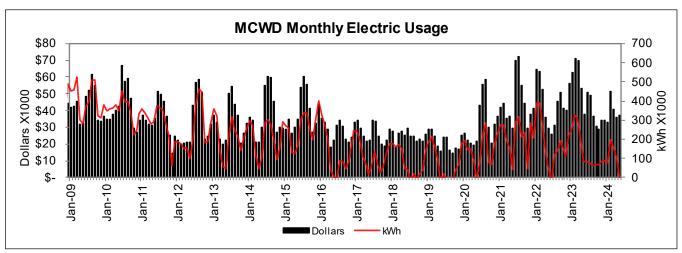
#### Solar plant production

#### **Report Summary**

Maintenance Divisions are focusing on preventive maintenance and completing summer repair projects.

#### **Solar Power Plant Maintenance**

The solar array is working well, and production is currently exceeding the forecasted production goals.



#### **Wastewater Treatment Plant and Recycled Water Maintenance**

The Plant Maintenance team has made several repairs and upgrades around the treatment plant including:

- Rebuilt EQ return pump #1 with all three pumps now meeting performance standards.
- Removed and replaced the existing 6-inch flow meter and piping with a new 10" stainless steel piping and flow meter. This removes the existing restriction in the EQ plumbing and allows for maximum return flow.
- Investigated level transducer fail on step screen and resolved the issue.

#### **Surface Water Treatment Plant and Related Facilities Maintenance**

Lake Mary remains our primary source of water. All systems in the surface water treatment plant are functioning as expected.

#### **Groundwater Treatment and Related Facilities Maintenance**

The groundwater plants are operated monthly to ensure that they remain in a state of readiness. These plants are constantly maintained and are available for immediate use if required. Plant Maintenance has performed some preventive maintenance and small repairs to the well and tank sites including:

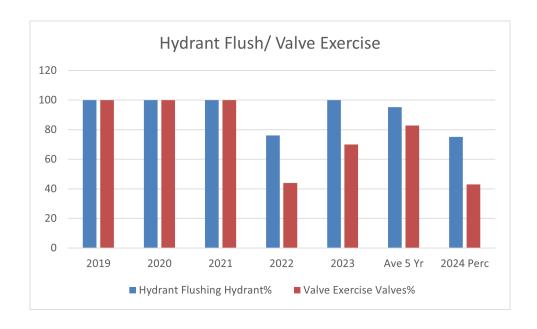
- Replaced charging system at T2.

#### **Water Distribution System Operations & Maintenance**

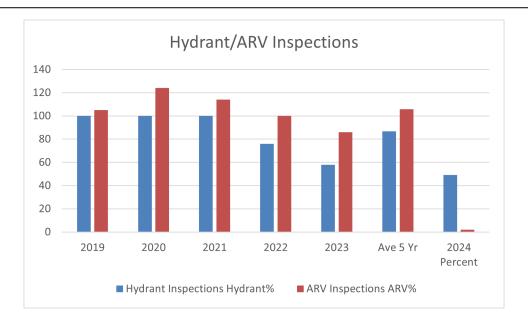
No large leaks were found or reported this month. Staff made repairs to a small leak at a meter pit on Forest Trail and are concentrating efforts on preventative maintenance.

Other notable events include:

- Installed hydrant meters for construction water at Limelight and Obsidian.
- Replaced a broken meter pit on Commerce Drive and Forest Trail.
- Responded to 8 customer service calls.
- Multiple metering system repairs were completed on R450 radios including 20 R450/ R900 radio swaps.
- We have 1,012 of the R900 radios now in service.



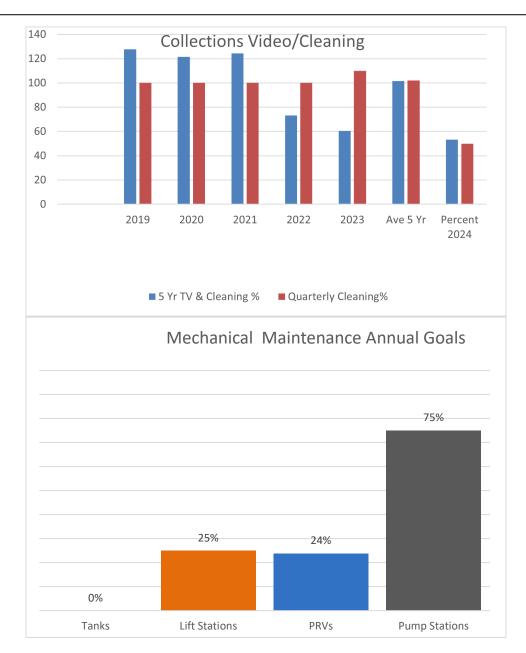

#### **Wastewater Collection System Operations & Maintenance**

The Line Maintenance team focused a great deal of time investigating inflow and infiltration (I&I) of ground water into the collection system. There is a small window of time each spring when this problem can be identified. This year the team found one of the largest groundwater intrusions to date. After the repair of this damaged lateral the results could be seen at the wastewater influent meter. This one source of I&I was calculated at .25MGD, nearly 20% of the 1.25MGD average daily plant influent. Several other small sources of I&I were located and repaired.

#### **In-House Construction Projects**

- Replacement of galvanized water laterals will resume with meter pit upgrades in progress on Valley Vista Drive.

## **Financial Department Update**

The Finance department has been working with the new auditors to provide information in preparation for the audit. The audit field work occurred the week of July 8, with the expectation that the draft audit report will be presented to the Board at the regular September Board meeting.

The District completed the purchase of a condominium at 299 Manzanita in June. It is a 3-bedroom, 2-bath unit with a two-car garage. A District employee will move into the condo in July.

The RFP for a connection fee study has been published, with responses due July 16. The review and selection processes are expected to be complete by the end of July.

As we move forward on capital projects, we are able to update estimates of project costs. The bids for the MCWD pavement work came in lower than budgeted. The bids for the sewer collection system came in higher than budgeted. It is expected that the total for all capital projects will be lower than budgeted.

Significant payments in May and June include:

- \$768,343 to Inyo-Mono Title for the purchase of employee rental housing at 229 Manzanita.
- \$69,943 to McGinley and Associates for hydraulic monitoring in February, March, and April. This cost will be reimbursed by Ormat as part of our monitoring plan agreement.
- A total of \$39,463 to Tesco Controls for work on our SCADA system.
- A total of \$32,356 to Western Nevada Supply for meter pits, materials for summer construction and warehouse inventory.

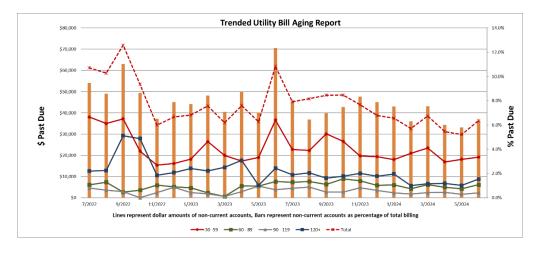

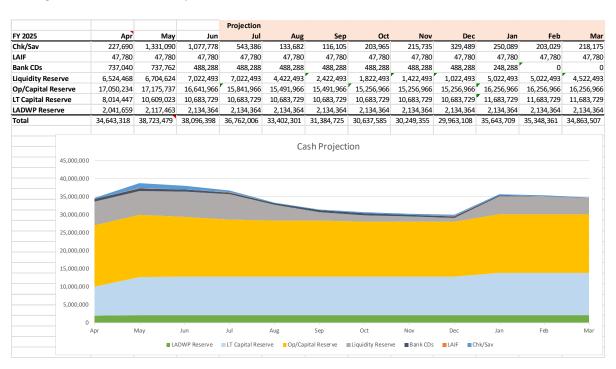
# **Table D Trended Utility Bill Aging Report**

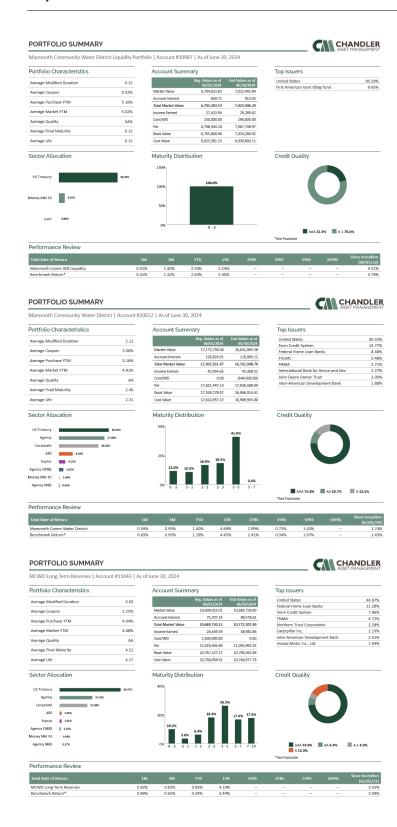

#### **Active Capital Projects**

Project	Status
Well 32	The updated Drinking Water Source Assessment has been submitted for the Department of Drinking Water permit. Operations and Maintenance have completed commissioning of the new SCADA control systems. Maintenance is scheduling construction of the concrete pad.
Seismic Risk Assessment	Structural engineering consultant interviews were held and Holmes Engineering was selected. The project scope is being defined and negotiated. Preliminary costs exceed the FY25 budget amount (\$100,000) and staff is reevaluating the project objectives and alternatives.
Campus Pavement Rehab	Two bids were received, and a contract has been awarded to Spiess Construction Co. Inc. for \$2,057,730.30. The updated total budget estimate for the project is now \$2.5M including contingencies, change orders, materials testing, and utility work done in-house. The contractor is developing a schedule and plans to phase the work to accommodate ongoing MCWD operations.
GIS Utility Network	Seven proposals were received, five interviews held, and Avineon was selected as the most qualified consultant for this important project. ISD is finalizing the services agreement with support from Engineering. See the ISD report for more details.

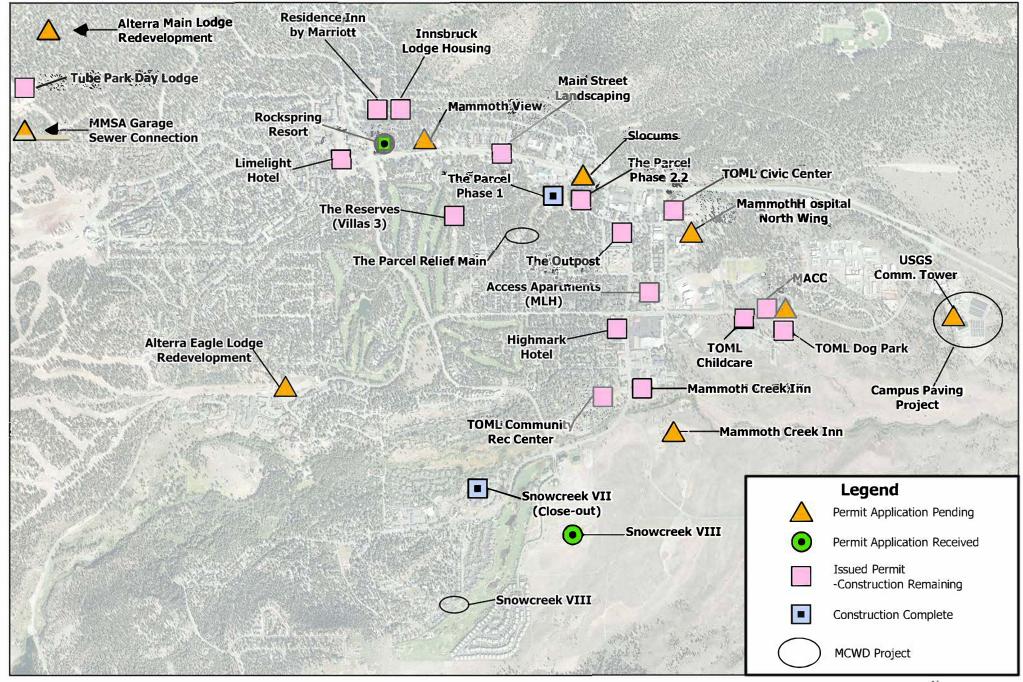

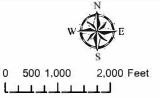

#### **Executive Summary**

ISD is pleased to announce that all remaining punch list items have been resolved and the SCADA upgrade project has been completed. ISD has also completed several system upgrades related to the resiliency and failover capabilities of the MCWD network. In addition, several new cybersecurity measures have been implemented to reduce MCWD's exposure to recent cyber threats hitting the public utility sector. ISD and Engineering have also completed the selection process for the ESRI GIS Utility Network Request for Proposals and have issued a Notice of Intent to Award the work to Avineon for upgrading the District's GIS system. Please see below for further details.

#### **Hardware Systems**

- SCADA System Upgrade The SCADA upgrade project has been finalized and final payment for the project has been issued. All punch list items have been addressed and staff are conducting operations, administration, alarming and trend reporting on the new system. The old SCADA system has been decommissioned. Moving forward, SCADA will be mentioned in this ISD report as a routine maintenance item or as any new issues arise.
- AMI System The Automated Meter Infrastructure (AMI) staff Committee continues monthly
  meetings to support the health of the District R450/R900 systems. Both R900 and all five R450
  collectors are functioning properly. The problematic District R450 collector was repaired under
  RMA, re-configured and put back in service in late May. As of July 10<sup>th</sup>, the District's metering
  system is functioning at 98.7% read efficiency, which reflects a well-maintained system. Staff will
  continue to utilize the monthly meetings to discuss system upgrades, optimize billing reads, and
  analyze usage patterns by billing groups.
- ISD ordered and replaced a damaged iPad in the Water Operations department.
- The current Workstation Replacement Schedule is on track with two servers, ten desktops and two
  laptops ordered this year. The new MCWDGIS and MCWDSVR12 servers have been configured and
  deployed, and eight of the twelve replacement workstations have been deployed. The remaining
  four workstations will be configured as time allows, completing the FY 2025 Workstation
  Replacement Schedule.
- Ongoing hardware support, maintenance, and updates.

#### **Software Systems**

- ISD staff are still in the process of transitioning MCWD PC equipment from one endpoint malware antivirus service to another more robust platform.
- Renewed and co-termed all Trimble GPS R2 hardware and firmware warranties with Trimble TerraFlex software warranties and applied new licensing on MCWD GPS systems.
- Transitioned all CAD licensing from shared License Manager model to new Autodesk user-based subscription model and downloaded and installed Autodesk Civil 3D 2024 CAD software for all CAD users. Also licensed and installed Autodesk Infoworks ICM and InfoWater Pro sewer and water modeling software on appropriate Engineer PCs.
- ISD and Engineering conducting meetings to optimize EnerGov Permitting and Licensing (EPL)
   module and discuss upcoming Crystal Reports to SSRS custom report conversion plan. MCWD

#### **Network and Cybersecurity**

- ISP Redundancy and Failover ISD continues to make improvements towards the reliability and performance of the MCWD network. Onward Networks recently installed new hardware and software equipment to manage its Digital 395 network. As part of these upgrades, ISD worked with the Onward Network Operations Center (NOC) to implement a diverse solution for North/South circuit redundancy. Both the primary and SCADA ISP circuits now have North/South redundancy built-in should the network go down heading south to Barstow or North to Reno. The North/South redundancy is designed to automatically switch over to the best route for traffic. The system was successfully tested and will be tested regularly as part of "skeleton mode" ISD brown-out exercises utilizing the diverse Onward North/South solution along with backup cellular FirstNet technology as a failover ISP. The cellular FirstNet router was configured and tested a few months ago as a backup ISP should the entire Onward network go down. Together, these network improvements are designed to support critical District network operations should the primary ISP fail, and the backup solutions are fully configured and in place when/if needed. ISD is also working with Onward on a pricing analysis to evaluate potential bandwidth upgrades in the future.
- New MCWD Password Program ISD has implemented an MCWD Password Program for all staff to
  follow new guidelines and recommendations for password security and management. All staff are
  participating in the new security requirements and using password management software. Several
  staff have also chosen to use encrypted password vaults for their private accounts as well. SCADA
  users follow an even stricter password and access policy, and all guidelines follow ISO and NIST
  recommendations for the new SCADA system. ISD is extremely sensitive to keeping District data

- secure given the current cybersecurity environment with several national attacks on water systems making headlines as well as recent attacks on local peer agency IT systems.
- ISD is working with the Cybersecurity and Infrastructure Security Agency (CISA) to reduce MCWD's
  exposure to cyber threats and take a proactive approach to mitigating attacks. MCWD has signed
  up for CISA's Cyber Hygiene Services program and will be conducting vulnerability scanning and
  web application scanning exercises and plan to address any exposed vulnerabilities as needed. For

- ISD continues to manage Multi-Factor Authentication (MFA) security protocols and deploy new cybersecurity campaigns for all staff on the MCWD network. All staff participate in regular monthly training to prevent common industry threats.
- Managing remote access client connection software and devices, administering additional machines and users as necessary for remote access.
- All network systems secure, no data loss or intrusions.

#### GIS

- Utility Network ISD and Engineering staff continue to pursue a long-term standalone upgrade to the MCWD GIS system by transitioning it to a Utility Network (UN). On April 1st, ISD released a Request for Proposals for ESRI Geographic Information System (GIS) Utility Network Model Migration. The project is a one-time modernization project for the District GIS system and will be utilized as a planning and management tool for upcoming Capital Improvement Projects. The RFP closed on May 14th, and the District received seven proposals from highly qualified consultants. The seven proposals were evaluated by the UN Selection Committee, and five finalists were selected for demonstrations and interviews. The committee participated in demonstrations from each consultant and scored the results accordingly. Ultimately, the UN Selection Committee selected Avineon for the UN migration and a Notice of Intent to Award was issued on June 18th. Thereafter, MCWD responded to a California Public Records Act (CPRA) request for further information on the proposals and scoring results. Currently, MCWD is working on a draft services agreement with Avineon to perform the work. For MCWD, the Utility Network will support all aspects of GIS utility management and be especially useful for current water and sewer modeling efforts.
- Utility Network GIS data cleanup activity currently underway: deconstruction of Miscellaneous
  Assets into several new Feature Classes (Couplings, Dead Ends, Fittings, Reducers, Comfort
  Stations, etc.), water line material type and size analysis, Sewer Top Hat Feature Class creation,
  addition of all Line Maintenance sewer rehabilitation work (cracks, roots, grout, Armco) into sewer
  mainline Feature Class, sewer line modeling work, and various other data cleanup as necessary.
- ISD and Engineering continue to pursue additional training opportunities for the continued integration of ArcPro in the MCWD GIS environment.
- Added Cleaning Frequency field to Sewer Lines feature class per Engineering and Line Maintenance request for recording and managing annual cleaning statuses.

#### Conservation

#### Leaks

Staff continue to utilize WaterSmart for leak detection. Staff are sending direct messages to customers using WaterSmart and include a link to the Tyler Customer Portal, where customers can enroll in leak notifications. In May, staff notified 57 customers of potential leaks, and in June 56 customers were notified. Most leaks were found to be a result of irrigation systems coming online and were promptly fixed.

#### **Violations**

Daily watering has been the most common Irrigation Violation cited in the last two months. Contact with customers regarding their irrigation is an opportunity for staff to educate District customers about responsible watering. To date, no fines have been issued. Prior to issuing a Second Violation, staff are reaching out to customers by phone to ensure the violation was received via email and inquiring about the status of the violation. Customers have responded positively in correcting violations. In May, one violation was issued for incorrect watering days, and no MAWA accounts went over their allowance. In June, 40 First Violations were issued, two Second Violations were issued. Eight MAWA violations were issued in June.

The District continues to accommodate variance requests to water daily for yard rehabilitation, with eight variances issued as of 07/10/24.

#### Rebate Program

The FY25 Indoor Rebate Program is continuing to be utilized by customers and advertised on the radio and newspaper. Six applications were received in May, and nine were received in June. The table below displays the results of the program thus far, along with the previous three years for comparison.

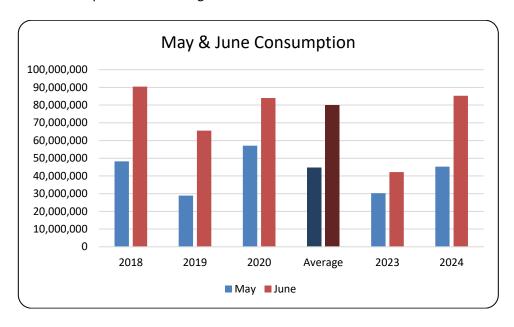

#### **MCWD Customer Water Consumption**

#### Fats, Oil and Grease Control Program (FOG)

Regulatory Services Division (RSD) continues to conduct regular inspections and monitor grease interceptors. Staff completed 8 inspections and issued one violation (Second Violation) in May. In June, 10 inspections were completed, and no violations were issued. One new food service establishment was permitted inside the Snowcreek Athletic Club.

#### Cross Contamination Control (Backflow) Program

To date, there are a total of 1,942 backflow assemblies in the system. Staff has entered all assemblies into the GIS system for ease of locating and analyzing the assemblies. To date, 1,629 1<sup>st</sup> Notices have been sent and 558 assemblies are past due. Final Notices have been sent for 188 assemblies and 35 shut-off

notices have been sent. 298 tests are currently past due, and there are 1,331 assemeblies that need to be tested this year. Staff is also following up on the 2020 backflow survey to verify that hazards no longer exist and that assesmblies were removed at certain locations.

RSD is continuing to track the State Water Resources Control Board's creation and approval of the new Cross-Connection Control Policy Handbook. The handbook is intended to replace existing cross-connection control regulations in CCR Title 17. SWRCB has published guidance documents and a template for the handbook, and adoption of a the new handbook, replacing the code section, is anticipated this fall.

#### **Local Agency Formation Commission (LAFCO)**

The Mono LAFCO is working to update Municipal Service Reviews (MSRs) for LAFCO entities in 2024. LAFCO met in June and received an update on the MSRs; completing the MSRs will take more time and there is no anticipated date of finaling the reviews. The District's MSR will be routed to District staff for comments and review prior to posting the draft online for public comment before consideration by LAFCO. The MCWD MSR is one of eight priority MSRs County staff is working on. Staff will continue to work with County staff and monitor progress.

#### MCWD-USFS MOA for Laurel Pond (1983)

The 1983 Memorandum of Agreement for discharge of treated wastewater effluent to Laurel Pond is due for renewal. District staff reviewed and updated an MOA draft that was supplied to USFS in 2022. On February 8, USFS staff responded that the District Ranger would review the MOA and decide if that is the correct instrument to use for this process. There have been no updates since that time.

#### **Public Affairs and Outreach**

#### **Conservation Advertisements**

During the last week of May, new radio advertisements were recorded with the assistance of KMMT-KRHV staff. The five new advertisements are currently rotating on KMMT and KIBS. The advertisements disseminate information about the new landscaping policy, indoor rebates, turf replacement rebates, enrolling in the customer portal, and Water Conservation Level 0 watering restrictions.

The Sheet newspaper has printed an advertisement displaying the watering schedule and rebate offers each week of the summer.

On May 8, RSD staff attended the Mono County Sustainability Fair,

held at the Mammoth Lakes Library. The event was well attended, and staff set up a table with various conservation giveaways, District swag, and the watering schedule. A broken meter and backflow device were also on display and generated a lot of interest and conversation with attendees.



#### **Press Release**

At the end of May one press release was issued for the annual Consumer Confidence Report. RSD utilized WaterSmart to also send email notifications to customers. In June, a press release was issued on the new Landscape Standards Policy. Staff also gathered a list of property managers and landscape businesses and

The General Manager's report is designed to summarize important District activities and to highlight developments that may require Board action in the future.

Key items for the past two months included working on the project to bring MCWD Code and policies up to date, supporting capital projects, workforce planning, and work in preparation for a new connection fee study.

Other ongoing items included working with the local development community, supporting District Capital construction projects, monitoring local agency meetings, groundwater monitoring related to geothermal pumping, and working with state regulators on the District's waste discharge requirements.

# **Departmental / General**

#### **Staff Resources and Management**

- Discussions with management staff regarding short-term and long-term workforce planning strategies
  continue. Considerations are for both current and anticipated vacancies, specific workflow needs to
  support District operations, department head input and recommendations, along with agency
  benchmarking comparisons.
- Held monthly General All-Staff, Board Staff, and Senior Management Staff meetings.
- Engineering, Operations, and Maintenance hold weekly collaborative meetings, reporting on and tracking progress of current and future capital projects and programs.

#### **District Employee Home Purchase Assistance and Rental Programs**

The Mammoth Community Water District (MCWD) values its employees and has adopted two policies which address local housing challenges. The policies include an Employee Home Purchase Assistance Policy designed to facilitate home ownership for District employees and a Housing Rental Policy which supports District employees living in or near the Town of Mammoth Lakes by providing rental housing assistance. Both policies are designed to promote and support retention, and also provide an incentive for recruiting potential employees to ensure the District maintains the most skilled and professional workforce possible.

- The District currently has 11 employees participating in the EHPAP program: 7 in the shared value option, 2 in the shared value/loan option, and 2 in the loan only option.
- The District currently has 11 rental units occupied by MCWD staff. The District maintains a waiting list which currently has 2 staff members who may be interested in District owned rental units. District management staff will continue to monitor local economic conditions with regards to potential opportunities to increase the number of rental units available for staff.

#### **Water Conservation and Supply Update**

The Operations Superintendent provided a quarterly water supply report (see agenda item C-2) which evaluates the existing surface and groundwater conditions and projects supply and demand ratios for the next quarter. The report shows that the District will have an adequate supply to meet demand and recommends that the District remains at Water Conservation Level 0.

The District's various levels of water conservation measures are designed to balance water use with ongoing conservation needs for maintaining a consistent water supply for our community during both heavy water years and drought years. Staff are continually monitoring the District's water supply and demand conditions and based on this analysis make recommendations to the Board regarding water conservation levels.

#### **Water and Wastewater**

Water Operations continues to utilize surface water as the community's primary water source.

Total water produced in June 2024 was 91.5 million gallons, which is up from the 47.8 million gallons produced in June 2023. Water sources included 80% surface water, 8% groundwater and 12% recycled water. Currently, Lake Mary has a balance of 606 ac/ft, which is 100% of the District's total surface water storage capacity.

Total wastewater treated in June 2024 was 38.4 million gallons, which is down from the 60.3 million gallons treated in June 2023. (See B-1 Operations Department Report for more details.)

#### **Financial Management**

The District's 2025 fiscal year reflects revenue tracking slightly above budgeted projections with expenses tracking just below budgeted projections. Finance Department activities over the past month focused on working with the new auditing firm in preparation for the annual audit. (See B-3 Finance Department Report for more details.)

#### **Letters of Support, Contracts and Agreements**

- Signed Master Services Agreement with UES to provide Hydrogeology Support to the District.
- Signed Task order #1 with UES for hydrogeologic support related to the installation of additional monitoring wells at Laurel Pond in the amount of \$62,785.

#### **Departmental Activities**

- Engineering Department staff continue supporting operation and maintenance activities along with working on the many active and planned construction projects at the District and throughout the community. (See B-4 Engineering Department Report for more details.)
- Regulatory Services Division staff continue to provide regulatory support for community fuels reduction
  projects, conservation efforts monitoring and notifying customers of water leaks, processing rebates,
  administering Backflow and FOG programs, and PR/advertising support. (See B-7 Regulatory Services
  Division Report for more details.)
- Personnel Services Department activities included updating job descriptions, workforce planning, and communicating with L12 Union as needed. (See B-6 Personnel Services Department Report for more details.)
- Information Services Department staff continue to support all of the District's technology needs. (See B-5 Information Services Report for more details.)
- Operations Department staff continue to monitor water and wastewater production for compliance with all State Water Resources Control Board regulations. (See B-1 Operations Department Report for more details.)
- Maintenance Department staff continue working on in-house construction projects and meeting maintenance goals and requirements. (See B-2 Maintenance Department Report for more details.)

# **Projects/Related**

#### **Fuels Reduction Projects**

The General Manger and District Regulatory Staff continue to participate in the Whitebark Institute's Eastern Sierra Climate and Communities Resilience Project (ESCCRP) and associated Financial Advisory Team meetings.

MCWD, along with other local stakeholder agencies, signed an MOU with Blue Forest Financial to explore

stakeholder benefits related to expanding funding options for forest fuels reduction projects. Blue Forest Financial will study and report how forest fuels reduction projects benefit local stakeholders related to funding. Blue Forest utilizes this approach to assign agencies with potential funding responsibilities managed through a Forest Resilience Bond. A Forest Resilience Bond could ultimately provide additional forest treatment capacity.

#### MCWD Code and Policy Review and Update

MCWD staff and the Board ad-hoc committee continue to work on reviewing and updating the District's Code and policies. This extensive project will bring the District's Code into alignment with current laws and practices.

The MCWD Code Book has three chapters remaining. Staff and legal counsel are currently working on extensive updates to Chapters 11 and 12, the MCWD Sewer Code and Water Code respectively. The current focus is to restructure the two Codes in relation to Engineering Permit Fees. These fees are being restructured to align more closely with the District's actual permit process and will also lead to a revision in the Master Fee Schedule. As part of this proposed restructuring, Chapters 11 and 12 would be repealed and renamed as the MCWD Sewer Code and the MCWD Water Code respectively. The final remaining chapter contains procedures for environmental review of District projects. Staff have started working on the policy to replace the Code language and it should be ready for Board review and adoption in the coming months.

#### **Water and Wastewater Capacity Fee Study**

MCWD staff have identified the need to perform a Water and Wastewater capacity fee study. The new study will update the connection fee structure which was last updated following the District's 2019 water and wastewater connection fee study. An RFP has been sent out to select a qualified consultant to support the project. Staff will be working with the Board ad-hoc committee over the next few months to complete this project with the goal of implementing the new fee structure in alignment with the FY 2026 budget year.

Capacity fees, also known as connection or developer fees, are one-time capital charges assessed against a new development to recover the proportional share of capital facility investment previously constructed or planned to be constructed to accommodate growth. Capacity fees are codified in California Code and must reflect a link between the fee and the benefit received by a new connection to the system.

#### LAFCO Municipal Services Review (MSR) and Sphere of Influence Recommendation

LAFCO has prepared a draft updated MSR for MCWD and has submitted it to staff for review. The MSR and any recommendations may influence future policy decisions related to water and sewer service for the greater Mammoth area including the Mammoth Mountain Main Lodge Redevelopment Project.

LAFCO also met on June 13, 2024, when there was a call for nomination for two vacancies: one Special District Member and one Alternate Special District Member. Two applications were received with Jeffrey Sutch, Mammoth Lakes Fire Protection District, being appointed to the open seat and Gary Thompson, Mammoth Community Water District, being appointed to the alternate seat. The Alternate may be requested to sit in for either Special District seat. The next LAFCO is tentatively scheduled at 3 p.m. on October 10, 2024. (See B-7 Regulatory Services Department Report for more details.)

#### Alterra/MMSA Main Lodge Development

Alterra/MMSA has proposed a Main Lodge redevelopment Master Plan and submitted environmental scoping documents for their project to the TOML which listed a new on-site package treatment plant to handle their wastewater needs. The District provided comments on project scoping documents and will continue to stay

apprised of any potential changes as the project develops. (See B-4 Engineering Department Report for details.)

#### MCWD Water Discharge Requirements (WDR)

Lahontan staff reviewed and provided feedback on a proposal by MCWD for completing a study of the Laurel Pond area to better identify the appropriateness of specific use classifications. Specifically, Lahontan staff expressed concerns regarding the sampling depth of recently constructed Laurel Pond monitoring wells. The proposed study would likely take up to four years after which time Lahontan will provide comments on updating the District's WDR which has the associated potential for treatment process changes at the WWTP. (See B-4 Engineering Department Report for more details.)

## **Background**

A statewide general election is scheduled to be held in Mono County on Tuesday, November 5, 2024. For many years the District has consolidated its election with Mono County and the elections have been run through the County's Elections Office. This year the Mono County Clerk-Recorder-Registrar is requiring, per Elections Code Section 10403, the MCWD Board to submit a resolution requesting the District's election be consolidated with the November 5 general election.

Attached is a proposed resolution to request election services from the Mono County Clerk-Recorder-Registrar to fill three vacancies of the Mammoth Community Water District Board of Directors, whose regular terms expire November 30, 2024. Additionally, the resolution states the qualifications of a nominee and if the candidate or District will pay the cost of publishing the Candidate's Statement of Qualifications. Once adopted, this resolution needs to be submitted to the Mono County Clerk-Recorder-Registrar before July 31.

The candidate filing period for this year opens July 15, 2024, and closes August 9, 2024 (or August 14, 2024, if an incumbent fails to file).

# Fiscal Impact

The most recent election that had more candidates file for a MCWD Director's seat than there were available was 2018. There were three open seats and the District's pro-rated share of the election costs was \$2,500.

WHEREAS, pursuant to Elections Code Section 10002, the governing body of any city or district may by resolution request the Board of Supervisors of the county to permit the county elections official to render specified services to the city or district relating to the conduct of an election and the city or district shall reimburse the county in full for the services performed upon presentation of a bill to the city or district;

**WHEREAS**, the resolution of the governing body of the city or district shall specify the services requested;

WHEREAS, pursuant to Elections Code Section 10402.5, any state, county, municipal, district, and school district election held on a statewide election date pursuant to Section 1002 shall be consolidated with the statewide election and the procedural requirements prescribed for that type of election shall be construed as if this section were specifically set forth in the provisions relating to that election;

WHEREAS, pursuant to Elections Code Section 10403, whenever an election called by a district, city or other political subdivision for the submission of any question, proposition, or office to be filled is to be consolidated with a statewide election, and the question, proposition, or office to be filled is to appear upon the same ballot as that provided for that statewide election, the district, city or other political subdivision shall, at least 88 days prior to the date of the election, file with the board of supervisors, and a copy with the elections official, a resolution of its governing board requesting the consolidation, and setting forth the exact form of any question, proposition, or office to be voted upon at the election, as it is to appear on the ballot, and acknowledging that the consolidated election will be held and conducted in the manner prescribed in Section 10418, and upon such request, the Board of Supervisors may order the consolidation;

**WHEREAS,** the resolution requesting the consolidation shall be adopted and filed at the same time as the adoption of the ordinance, resolution, or order calling the election;

**WHEREAS**, pursuant to Elections Code Section 10400, such election for cities and special districts may be either completely or partially consolidated;

**WHEREAS**, various district, county, political subdivision, and statewide elections have been or may be called to be held on November 5, 2024; and

WHEREAS, a statewide general election will be held within the County of Mono on Tuesday, November 5, 2024, and it is the Mammoth Community Water District's policy to hold its elections for Directors on the same date as the statewide general election on the first Tuesday after the first Monday in November in even numbered years in order to promote interest in the election and to reduce costs for ratepayers.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED THAT** the Board of Directors of the Mammoth Community Water District hereby orders an election to be called and consolidated with any and all elections also called to be held on November 5, 2024 insofar as said elections are to be held in the same territory or in territory that is in part the same as the territory of said District and requests the Board of Supervisors of the County of Mono order such consolidation under Elections Code Section 10400; and

**BE IT FURTHER RESOLVED AND ORDERED** that said Board hereby requests the Board of Supervisors to permit the Mono County Elections Department to provide any and all services necessary for conducting the election; and

**BE IT FURTHER RESOLVED AND ORDERED** that the Mono County Elections Department conduct the election for the following offices on the November 5, 2024 ballot:

#### **Background**

Due to the sustained low snowpack resulting in multi-year drought conditions from April 2012 through 2015, the staff recommended the Board implement various levels of water restrictions to conserve water supplies. With the record drought recorded in the winter of 2014-15, the Board implemented Level 3 water conservation measures in April 2015 through April 2017. After a massive winter in 2017, the Board modified the conservation level to Level 0 and requested that the Water Supply Update be produced on a quarterly basis. The District is currently operating under water conservation Level 0 which was approved in March 2024 following staff recommendations on the Water Supply Update. The purpose of this update is to provide an analysis of supply and demand patterns.

#### Discussion

Staff reviewed the status of both surface water and groundwater sources and compared the available supplies against historical monthly demands. From this analysis staff projected demands and our ability to meet those demands.

**Surface water**: Surface water from Lake Mary provided 94% of our supply in the 2nd quarter and is contributing 91% of the current supply. A total of 472 ac-ft of surface water was supplied from April through June. Lake Mary is full and stream flows are above the requirement to allow for direct diversion. A total of 606 ac-ft is stored in Lake Mary and will remain available for use once stream flows are below the requirement.

Surface water will be the primary source of supply for the next quarter using a direct diversion. The current flows are slightly above the stream flow requirement and are expected to fluctuate below the requirement toward the end of the 3<sup>rd</sup> quarter.

**Groundwater**: Engineering staff closely track groundwater levels in all nine of the District's production wells, and have conducted an aquifer monitoring analysis of over 30 years of groundwater data spanning multiple drought periods. This analysis indicates that multiple wet or normal years are required to recover the aquifer following a multi-year drought. This example was demonstrated by the 2012 – 2015 drought and the massive winter of 2017. The recharge that was experienced in 2017 did not recover the aquifer to predrought levels and it took 2 more normal and above normal snow years to see complete recovery. This pattern will continue until multiple wet or normal years reduce dependence on groundwater production and allow the aquifer to recharge to pre-drought conditions. Engineering recently updated aquifer monitoring analysis by including all values recorded in 2023. The analysis determined that the

large winter and subsequent run off, coupled with a reduction in groundwater usage, has given the opportunity for some aquifer recharge. By meeting most demand with surface water supplies there was only 40 ac-ft of groundwater used since the beginning of the year. Aquifer levels continue to show a positive trend with the lack of pumping and some continued recharge during the spring run-off.

**Demand:** Water production for the previous quarter was as follows:

April, 108 ac-ft

May, 143 ac-ft

June, 249 ac-ft

The total demand for this quarter was 500 ac-ft. This is 0.6% or 3 ac-ft more than the projected volume of 497 ac-ft.

**Demand Projections:** The demand projection for the July - September quarter is 815 ac-ft and is based on the average water consumption since 2011.

July, 300 ac-ft

August, 287 ac-ft

September, 228 ac-ft

# **Conclusion and Recommendation**

Current surface water supplies can meet most of the demand with very little supplemental usage of groundwater. Groundwater levels are continuing to trend upward with the reduced dependence on well water. Staff are recommending no change to the current water conservation level of 0 as both ground and surface water supplies are sufficient to meet the summer irrigation demands.

# MCWD AT A GLANCE



#### Mission statement:

The Mammoth Community Water District is committed to carefully and effectively managing and maintaining our local water resources. The District provides water and wastewater services to meet the health and safety needs of the community. All work is conducted in a safe, financially sound, and high quality manner. We are committed to our customers and the environment in which we live.

The Mammoth Community Water District (MCWD) was founded in 1957 and has consistently provided reliable water and wastewater services to the community of Mammoth Lakes, California. All of MCWD's water resources are located in the Mammoth Basin, no water is imported to the service area. Sources of water include surface water, groundwater, and recycled water. Surface water from Lake Mary, and groundwater from nine production wells, is treated by the District and distributed to customers using over 80 miles of water lines, eight storage reservoirs, and three treatment plants. Water is transported within an elevation range between 7,520 and 8,620 feet.

#### **Strategic Planning:**

At the beginning of each year, District staff engage the Board of Directors in a thorough review of the District's Strategic Plan for the purpose of developing long-term strategic operational goals and capital improvement planning. Review and discussion of the Plan is conducted via a public workshop, where members of the public are welcome to attend and comment. The Plan is a living document and helps staff align the District's strategic goals with its day-to-day activities, mission statement, core values, and overall operations plan. The plan integrates directly with the annual budgeting process. In FY24, two metrics were added to the Plan, "Water Resource and Wastewater Management & Planning" and "Operations & Maintenance".



## Twin Falls Lift Station Electrical Motor Control

The large winter of 2022-2023 caused the facility to lose power for over 40 days. Heavy snowfall and limited ability to move equipment and snow around at this location resulted in the site freezing and flooding, permanently damaging the electrical and mechanical equipment. The facility was not supported by a temporary generator due to its remote location and limited space surrounding it. Staff were able to access the site in late spring and assess the damage. Then, the entire electrical motor control system was replaced, and vulnerable equipment was relocated to a location less susceptible to flooding. This site was returned to normal operations in late fall and is now hardened from future long term power outages.

## Sewer Collection System Upgrades

This year the District contracted

with three different contractors for

specialized repair services to our wastewater collection system. Staff identified eleven locations of heavy ground water infiltration into the system and used a high-pressure grout injection system provided by one of the contractors to fix four line segments and seven manholes. Staff also installed eleven top hat repairs at service lateral entry points, rechanneled six manhole bases, replaced six manhole frames and covers, and preformed four sewer spot repairs. These repairs prevent water and root intrusions from happening. Lastly, the District had 6,497 feet of Cure In Place Pipe Lining (CIPP) installed. This is a tried-and-true method of restoring the integrity of older collection systems. This builds the District's inventory of lined pipe to over 78,500 feet or 19% of the total system.

## Lake Mary Treatment Plant

**Clearwell Generator** The long-term power outages of the 2022-2023 winter brought to light the need for a power solution at this location. Uninterruptible Power Source (UPS) devices have been used in the past, however they only provide a short term, 4-6 hour, solution. To provide power for a longer duration, the District purchased a small generator and installed controls that monitor the batteries of the UPSs. Now the generator will be used to charge the system, preventing interruption. This allows for efficient use of the limited fuel supply of the generator and assures that, when running, all of the generator's power is being

used.

# **ENGINEERING**

The District has a talented in-house staff able to complete many technical projects. This saves the District money over hiring outside contractors and allows work to be completed on a time frame that works best for overall operations. This year, the Engineering Department designed several projects for staff to complete, leaving only the need for specialized tasks to be done by contractors.





# **Equalization Building**Roof Replacement

The historic snows of the 2022-2023 winter combined with the springtime rain event resulted in many building structural failures around town. One of these structures was the roof of the MCWD Equalization Basin Pump Building (EQ Building). This building houses the essential pumping equipment for the operation of the MCWD Wastewater Treatment Plant (WWTP). The EO Building was originally constructed in 1980 and has been repaired over the years. The record snowfall combined with the spring rain event resulted in significant loading which caused the truss tails along the southwest corner of the building to fail. After the failure of the roof, District staff mobilized to remove snow from the building to prevent the damage from worsening. District staff took the opportunity to revise the design of the roof in order to resolve minor operational deficiencies. The center crown of the previous design resulted in drainage and ice issues on the front side of the building, the revised design was a mono slope design that drains entirely to the backside of the building. Additionally, rather than follow minimum current loading standards, District staff proactively used the upcoming ASCE 7-22 snow load standards, resulting in a far greater design load. The waterproofing roof membrane was installed by a reputable company which provides a 20-year quarantee on their product. This project was identified as a critical emergency project, and the roof was replaced during the 2023 construction season after the damage was incurred. The exterior work was completed prior to any significant precipitation events and interior work has since been completed.

# **ENGINEERING**

## **Hwy 203 Sanitary Sewer Line Upgrade Project**

The Engineering and Maintenance Departments collaborated to design 130 feet of new sanitary sewer line from Center Street into Hwy 203, installed by the MCWD construction crew. The project was necessary to increase sewer capacity, accommodating for future growth, and to provide operational redundancy. A larger diameter line was installed, which ties into the Main Street trunk line approximately 30 feet downstream of the existing Center Street tie-in, parallel with the original line left in-service. This approach allowed the new line to be constructed with no diversion, reducing cost and risk of a sanitary sewer spill. Additionally, the parallel lines allow for easy diversion during future maintenance work. The MCWD successfully completed the project during September and October 2023. Traffic Management Inc. was hired to perform traffic control throughout the project, including during the final paving process which was completed by Black Gold asphalt of Mammoth Lakes.







# **ENGINEERING**

## **Tank T-8 Replacement**

Tank T-8 (Forest Trail Tank) is a potable water reservoir located on USFS land above Forest Trail, and is the only tank connected directly to the most populated pressure zone (Zone 4) in the Mammoth water distribution system. This tank is crucial for absorbing pressure changes in Zone 4 and operating Well 1. T-8 was originally constructed as a 1.000.000-gallon bolted steel tank in 1995 but had only been operating at half capacity for the last 15 years due to leaking issues. The tank partially failed in April 2023 under large snow loads, rendering the tank unusable. It was determined that a welded steel tank was more appropriate for the size and climatic conditions of the tank, and a design-build RFP was put out in June 2023. Staff obtained all necessary permits to complete the work, and the demolition began in August 2023. The entire tank and the foundation were demolished except for the footings, which were re-used. The new tank is approximately nine-feet taller to prevent accidental discharge resulting from potential earthquakes and has a significantly higher snow load capacity than the previous tank. Work was completed in November 2023, and the tank is now operable for the foreseeable future.

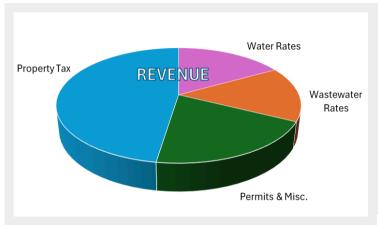






# DISTRICT FINANCES

The District receives sufficient revenue to provide water and wastewater services and to maintain reserve funds for financial resilience and required infrastructure projects.







# **CONSERVATION**

#### Leaks

Utilizing the Automated Metering Infrastructure hourly water use data, staff are able to identify leaks and notify customers before they receive a high bill or experience property damage. Customers are also now able to enroll in automated notifications from our leak detection system. In 2023, 336 customers were notified of leaks.

## <u>Indoor Rebate Programs</u>

The District continues to incentivize water conservation by providing customers with rebates when upgrading to new dishwashers, toilets, and/or clothes washers. This year, \$33,388 were provided to customers for rebates, and the estimated total water savings resulting from these upgrades is 608,004 gallons!

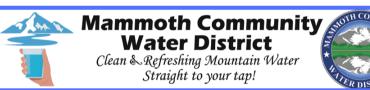

# PARTNERSHIPS IN THE COMMUNITY

## Eastern Sierra Climate and Communities Resilience Project (ESCCRP)

The District continued to support the ESCCRP in their efforts to complete fuels reduction within and surrounding the Town of Mammoth Lakes. District staff supported the closeout of Sierra Nevada Conservancy (SNC) Grant 1094, a grant received by the Mammoth Lakes Fire Safe Council in 2018 for fuels reduction in the Lakes Basin, the headwaters of Mammoth Creek. The District is part of the ESCCRP Financial Advisory Team which meets monthly. This year, the ESCCRP focused on CEQA/NEPA analysis of 10,000 acres surrounding the Town and completing fuels reduction at three Town-owned parcels. A Statement of Purpose was finalized for the Financial Advisory Team to further define the role of the group, including the goal to reduce the funding gap for forest treatments. Additionally, the Statement of Purpose agrees to partner with Blue Forest, a non-profit conservation finance organization that leverages Forest Resilience Bonds to make restoration projects happen. Through this partnership, the ESCCRP will have greater opportunities to fund forest treatment projects in and surrounding the District's service area.

In addition to MCWD's participation with the ESCCRP and assistance on the SNC Grant, RSD staff provided signage in the Lakes Basin during fuel reduction treatment in October and November. The signage provided information to the public about the need for the project, the goals, and the local agencies supporting the project.



## Community Support

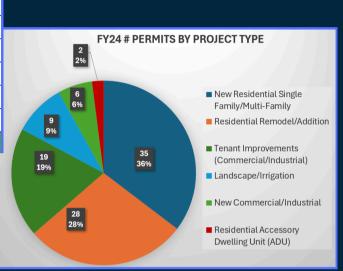
The District continues to be an integral part of the Mammoth community by providing support where opportunities exist. The District's Water Bar has continued to provide refreshing drinking water at events free of charge. The Water Bar was set up at the Mammoth Lakes' 4th of July parade outside of Footloose Sports, at the Bluesapalooza beer and music festival, and at the Mammoth Shakespeare Festival. The second Water Bar, stationed at The Village, continued to be utilized for the numerous events held there, including the Jazz Fest, Reggae Festival, Wine Weekend, and Mammoth Rocks festival.

The District also purchased a hockey rink board-banner in support of the Mammoth Lakes Community Recreation Center (CRC). The hockey rink board-banner displays the District logo and slogan, "Clean and refreshing mountain water straight to your tap!" The CRC had its grand opening on January 27. MCWD staff attended the event and set up a booth to provide free conservation items, District swag, and general information about the District's operations and conservation efforts.

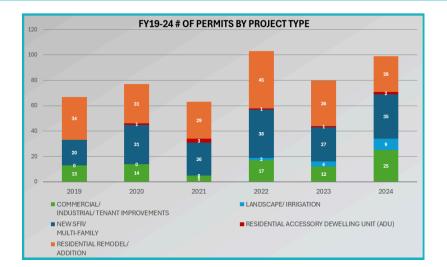
The Regulatory Services Division continued to attend public events where we had the opportunity to disseminate information to customers related to conservation and general operations. 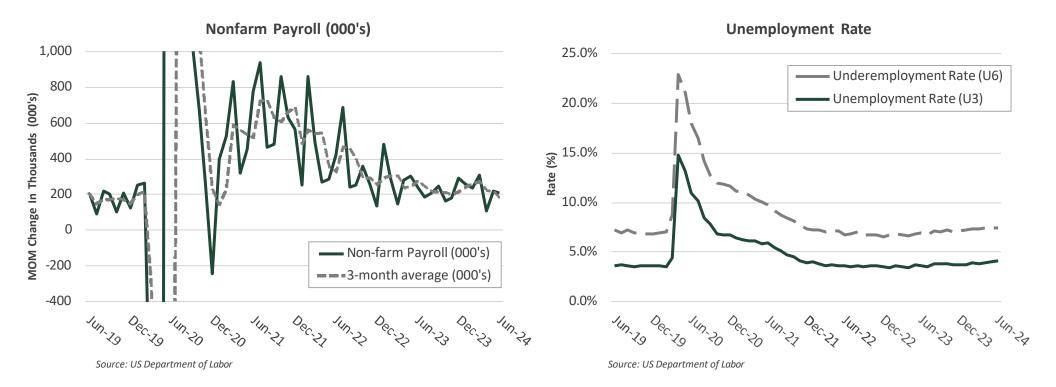
## SECTION 1 | ECONOMIC UPDATE

## **Economic Update**



- Recent economic data suggests positive but slower growth this year fueled by consumer spending. While the consumer has been resilient, growing credit card debt, higher delinquencies, and a moderating labor market pose potential headwinds to future economic growth. Inflationary trends are subsiding, but core levels remain above the Fed's target. Given the cumulative effects of restrictive monetary policy and tighter financial conditions, we believe the economy will gradually soften and the Fed will loosen monetary policy in 2024.
- As expected at the June meeting, the Federal Open Market Committee voted unanimously to leave the federal funds rate unchanged at a target range of 5.25-5.50%, emphasizing the need to see sustained evidence of easing inflation before considering any rate cuts. The FOMC's latest projections now suggest only one interest rate cut in 2024, with four more cuts expected in 2025 and a slightly higher long-term neutral rate. Additionally, the Fed continues to reduce its holdings of U.S. Treasury securities and agency mortgage-backed securities as per its predefined schedule of \$25 billion and \$35 billion per month.
- The US Treasury yield curve shifted lower in June as economic data moderated. The 2-year Treasury yield fell 12 basis points to 4.76%, the 5-year Treasury dropped 13 basis points to 4.38%, and the 10-year Treasury yield declined 10 basis points to 4.40%. The inversion between the 2-year Treasury yield and 10-year Treasury yield remained relatively stable at -36 basis points at June month-end versus -37 basis points at May month-end. The spread between the 2-year Treasury and 10-year Treasury yield one year ago was -106 basis points. The inversion between 3-month and 10-year Treasuries widened to -96 basis points in June from -91 basis points in May.

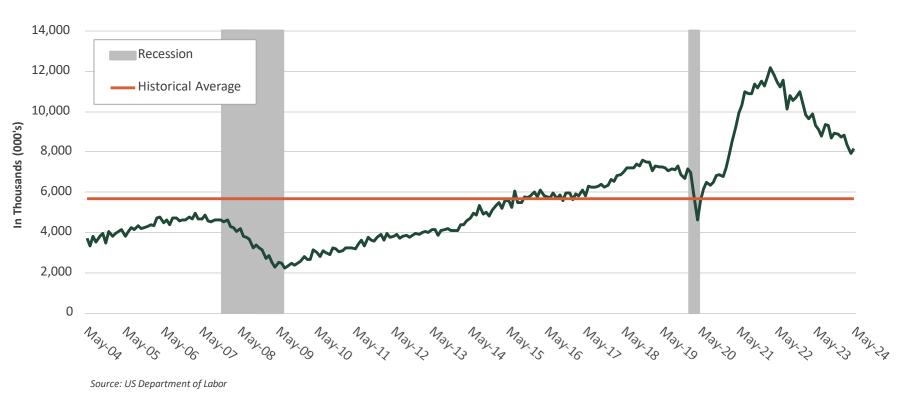




The U.S. economy added 206,000 jobs in June, remaining ahead of consensus expectations of 190,000 jobs. The gains were broad based, with government, health care, and social assistance posting the largest gains. The three-month moving average and six-month moving average payrolls have weakened from the first quarter to 177,000 and 222,000 respectively. The unemployment rate edged up to 4.1% in June, and the labor participation rate inched up to 62.6%, remaining below the pre-pandemic level of 63.3%. The U-6 underemployment rate, which includes those who are marginally attached to the labor force and employed part time for economic reasons held steady at 7.4%. Average hourly earnings rose 3.9% year-over-year in June, down from 4.1% year-over-year in May. The labor markets continue to show signs of cooling in line with the Federal Reserve's view that there has been "substantial" progress towards better balance in the labor market between demand and supply for workers.

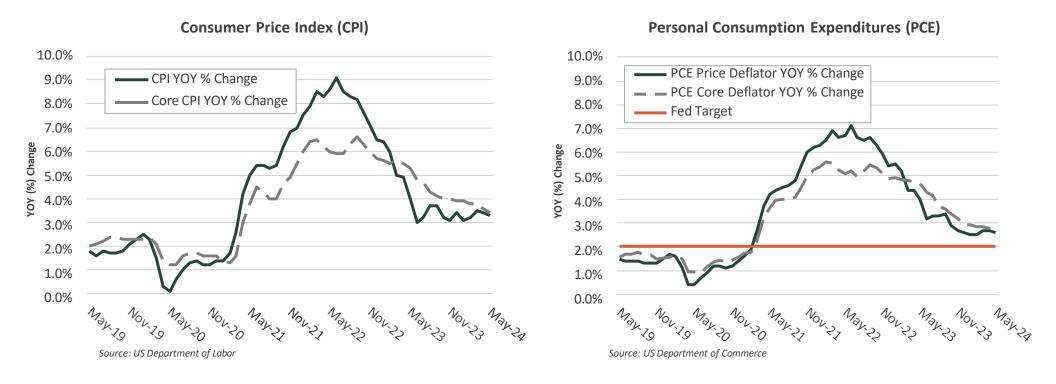


## **Job Openings**



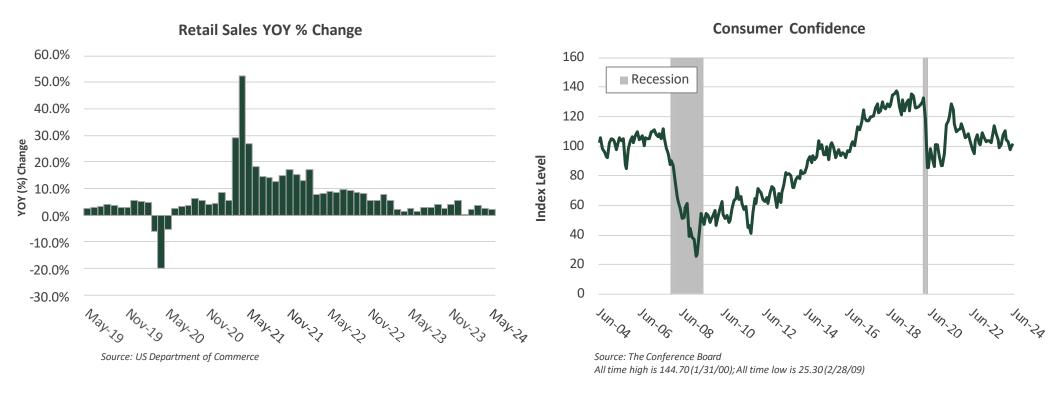
The Labor Department's Job Openings and Labor Turnover Survey (JOLTS) increased to 8.140 million job openings in May from a downwardly revised 7.919 million in April. Job openings still represent a healthy ratio of around 1.2 jobs for each unemployed individual. While the current level of job openings remains elevated from a historical perspective, the trend is decelerating.





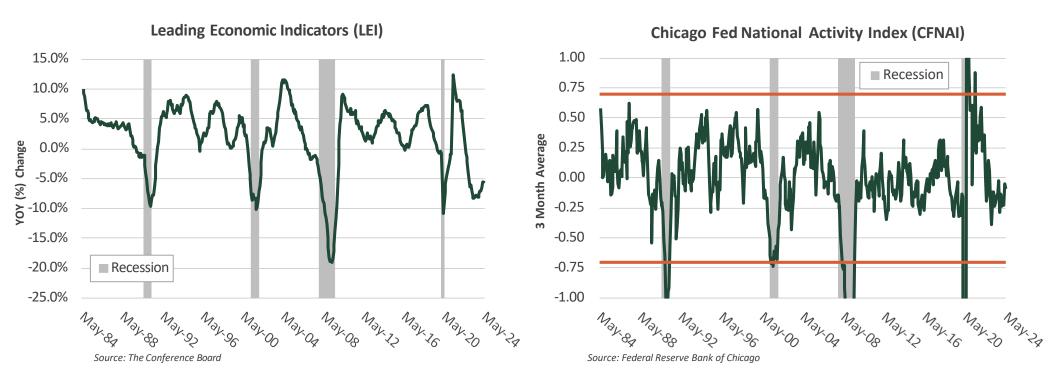
In May, the Consumer Price Index (CPI) remained unchanged month-over-month and rose 3.3% year-over-year, reflecting broad-based cost reductions. The Core CPI, which excludes volatile food and energy components, was up 0.2% month-over-month and 3.4% year-over-year in May, down from 3.6% in April and lower than expected. The Personal Consumption Expenditures (PCE) Index decelerated in May as expected. The headline PCE deflator was unchanged in May from April versus up 0.3% in the prior month. Year-over-year, the PCE deflator rose 2.6%. The Core PCE deflator (the Fed's preferred gauge) increased 0.1% in May from the prior month versus up 0.3% in April. The Core PCE deflator also rose 2.6% year-over-year, still above the Fed's 2% inflation target. Much of the lingering inflation has been driven by shelter costs and demand for services.





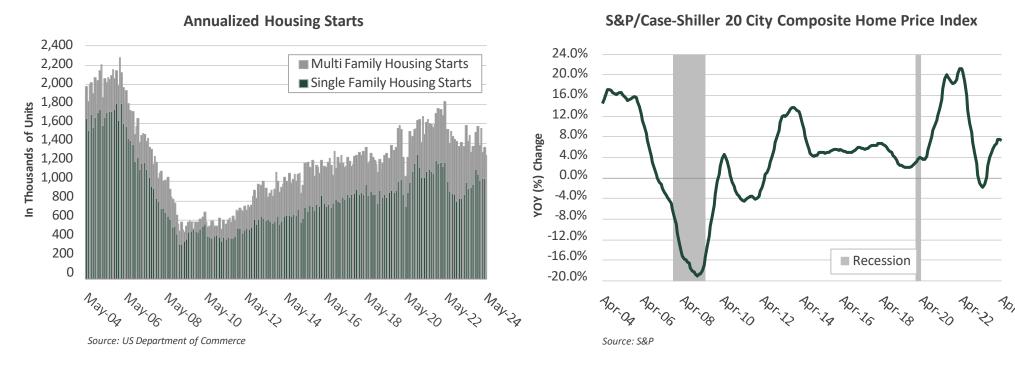
May Retail Sales increased below expectations to +0.1% after a downwardly revised -0.2%, pointing to a fatigued consumer. On a year-over-year basis, Retail Sales growth further slowed to +2.3% in May. Nonstore retailers were a bright spot in May, up 0.8% following a 1.8% decline in April. The Conference Board's Consumer Confidence Index fell to 100.4 in June from 101.3 in May. While the present situation component rose marginally, consumers are less optimistic about future expectations for business conditions and potential income increases. While the consumer has been resilient, consumption has begun to moderate in the face of higher interest rates, rising credit card balances, and growing delinquencies.





The Conference Board's Leading Economic Index (LEI) declined for the third consecutive month to -0.5% in May following a -0.6% decline in April. The index declined 5.3% year-over-year. The primary drivers for the negative print were a decline in new orders, weak consumer sentiment about future business conditions, and lower building permits. The Chicago Fed National Activity Index (CFNAI) increased to 0.18 in May from -0.26 in April, surpassing consensus expectations. However, the three-month moving average fell to -0.09 in May from -0.05 in April, indicating below-trend growth expectations for the economy.





May Housing Starts declined 5.5% month-over-month from April to 1.352 million units. This equates to -19.3% less starts compared to May 2023. Single family starts were 5.2% lower month-over-month due to higher mortgage interest rates, lack of existing unit supply and home affordability. Multi-family home starts declined 10.3% month-over-month. The Freddie Mac average rate for a 30-year fixed mortgage edged down to 6.92% in June from 7.06% in May. According to the Case-Shiller 20-City Home Price Index, housing prices rose a higher-than-expected 7.2% year-over-year in April versus March's upwardly revised 7.5% increase. Tight inventories and higher mortgage rates continue to impact affordability.



## Institute of Supply Management (ISM) Surveys



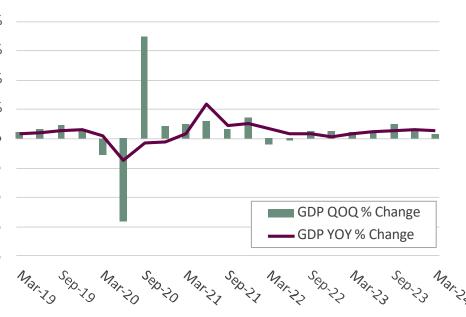
The Institute for Supply Management (ISM) Manufacturing index edged down to 48.5 in June from 48.7 in May. While new orders picked up, prices paid for materials fell the most in over a year. The ISM Services Index returned to contraction declining to 48.8 in June, from 53.8 in the previous month. Although the level of the decline was a surprise, the trend in the Services PMI, which applies to a larger share of US economic output, has been steadily decreasing.

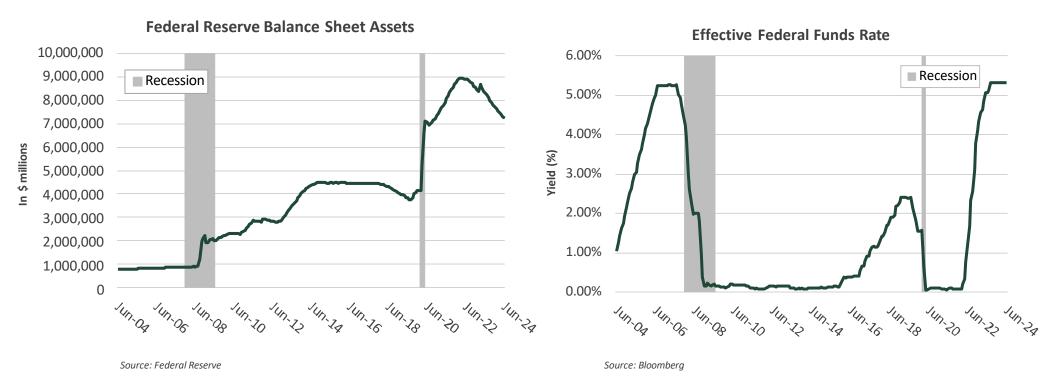

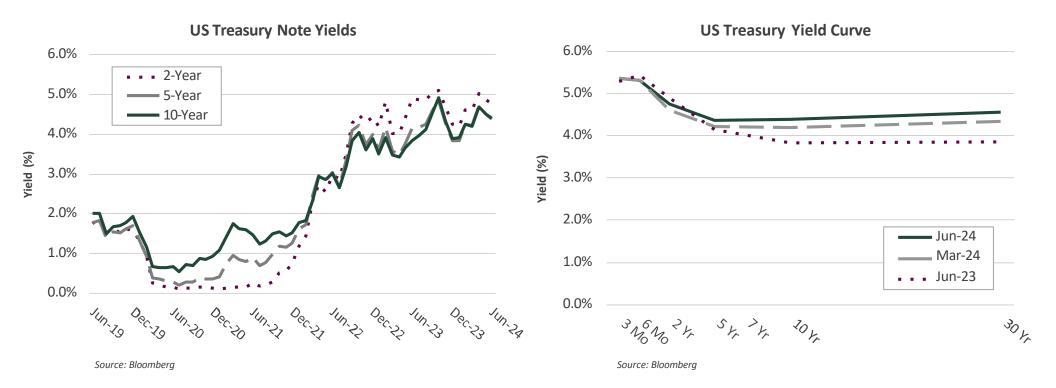
The third and final estimate of first quarter GDP came in as expected with growth up 1.4%, a small upward revision from 1.3% in the second estimate. Notably, the personal consumption expenditures component was revised down substantially to +1.5% in the final estimate from +2.0% in the second estimate. Weaker growth in consumer spending was offset by upward revisions in other major categories, particularly gross fixed investment. The consensus projection calls for 2.0% growth in the second quarter and 2.3% growth for the full year 2024.





As expected at the June meeting, the Federal Open Market Committee voted unanimously to leave the federal funds rate unchanged at a target range of 5.25-5.50%, emphasizing the need to see sustained evidence of easing inflation before considering any rate cuts. The FOMC's latest projections now suggest only one interest rate cut in 2024, with four more cuts expected in 2025 and a slightly higher long-term neutral rate. The Fed's inflation projections ticked up marginally, while unemployment and GDP growth forecasts remained steady. Additionally, the Fed continues to reduce its holdings of U.S. Treasury securities and agency mortgage-backed securities as per its predefined schedule of \$25 billion and \$35 billion per month. Since the Fed began its Quantitative Tightening campaign in June 2022, securities holdings have declined by approximately \$1.7T to approximately \$7.3T.





At the end of June, the 2-year Treasury yield was 15 basis points lower, and the 10-Year Treasury yield was 56 basis points higher, year-over-year. The inversion between the 2-year Treasury yield and 10-year Treasury yield remained relatively stable at -36 basis points at June month-end versus -37 basis points at May month-end. The inversion has occurred since July 2022 and remains historically long. The average historical spread (since 2003) is about +130 basis points. The inversion between 3-month and 10-year Treasuries widened to -96 basis points in June from -91 basis points in May.

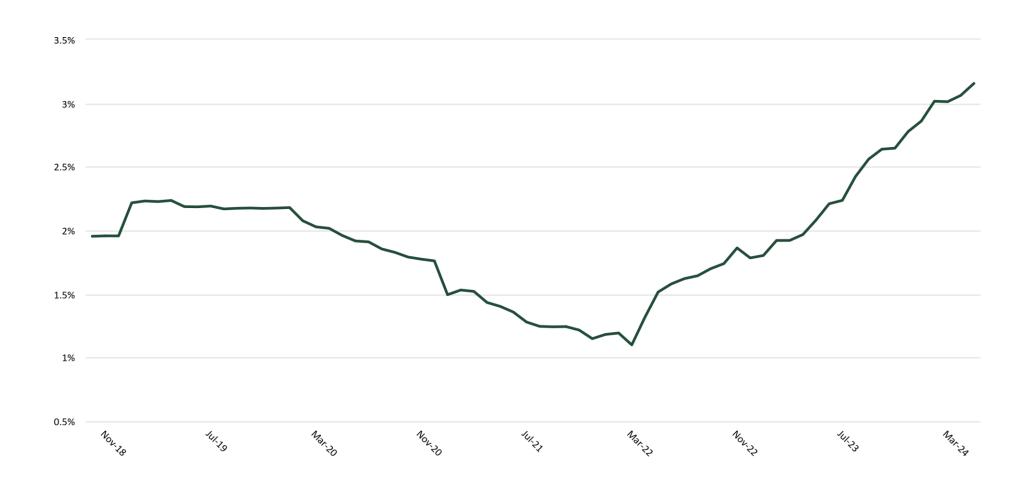

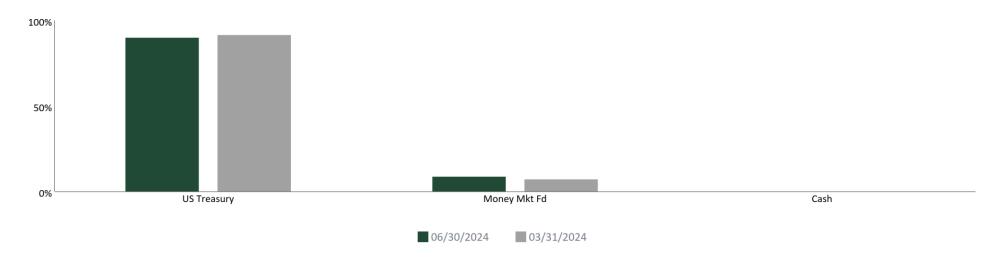

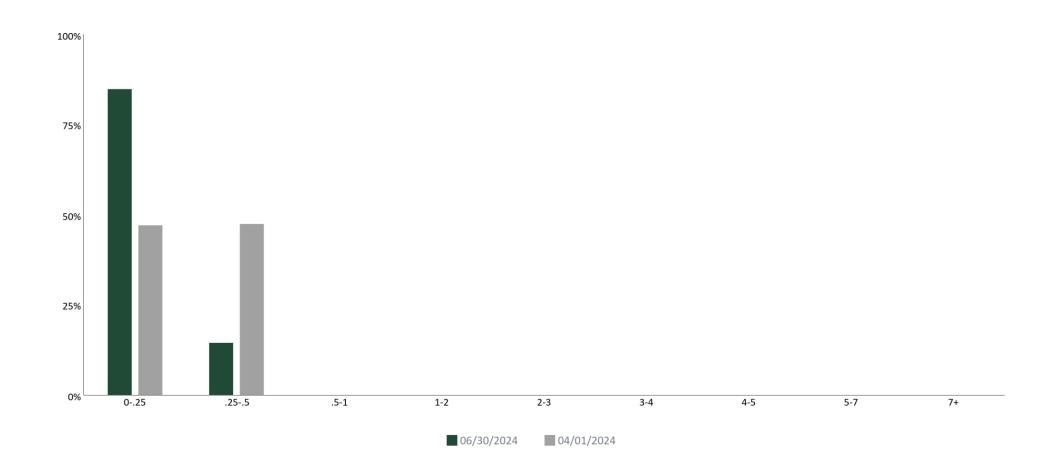

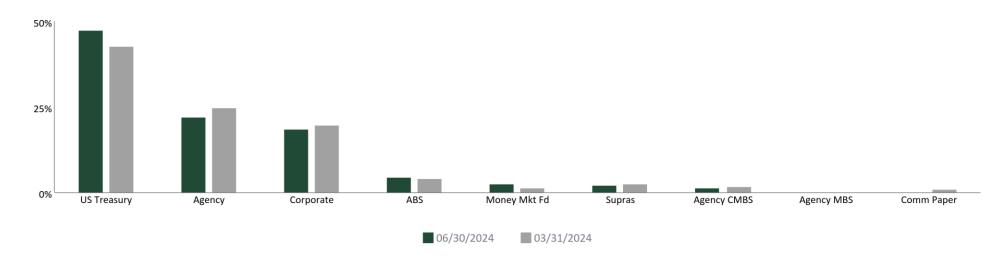
